# **CCW Reciprocity Update--Again**

Attorney General Tom Corbett continues to do a good job at pressing other states to enter into reciprocity agreements with PA for Concealed Carry of Firearms. In November/06 PA signed reciprocity agreements with **South Dakota** and **Tennessee** and in the first week of January 2007another agreement has been signed adding **Virginia** to PA's list of states that have entered into reciprocity agreements for concealed-weapons permit holders.

That means the states listed below and Pennsylvania will now honor each other's concealed weapons permits. Pennsylvania now has reciprocity agreements with 13 states. **They are**:

The importance of Virginia cannot be overstated because this state requires 'mandatory' training and we have been told by many that we would never have an agreement with a state with this requirement unless we acquiesced to mandatory training here in PA. The ACSL held to our positions and we found that this issue was a minor one in the overall scheme of things and that the changes that we made to the CCW law in HB 1717 were substantial and helpful in this process. More states are coming!

# PA Anti-Gun Legislators Begin Attack on Gun Ownership

As a continuation of the attack on gun owners and sportsmen and women in this state, State Rep. Dwight Evans, legislators from the Southeast and local mayors on January 10<sup>th</sup> pledged to join forces in a unified effort to pass legislation that will strengthen Pennsylvania laws and curb increased violence statewide associated with illegal guns and drugs.

They have a package of gun control bills sprinkled with minor changes in the mandatory sentencing laws that will only serve to distract public attention away from the real root causes of these problems—a revolving door justice system. Many of these bills were rejected during the committee of the whole and as predicted the outcome from the election has these same legislators feeling emboldened by their takeover of the PA House of Representatives.

## Activists Alarmed at Reported Pelosi Pledge on Lobby Reform

Gun Rights activists in Ohio are sounding the alarm about a reported plan by House Speaker Nancy Pelosi to consider lobbying reform that includes new regulations regarding grassroots organizations.

Word about the new proposal was reported by *Human Events* magazine, and it did not take long for Ohioans For Concealed Carry (OFCC) to sound the alarm. The magazine said new legislation would change the legal definition of "grassroots lobbying." According to the report, any organization that "encourages 500 or more members of the general public to contact their elected representatives" would be required to file a quarterly report with the government about this activity.

Gun rights organizations, including the National Rifle Association, Citizens Committee for the Right to Keep and Bear Arms, Gun Owners of America (GOA), and various state and local groups, might feel the pinch if such regulations were approved. GOA's Larry Pratt is among co

signers of a letter criticizing the proposal. In a statement about the proposal, OFCC noted, "The biggest strength of Ohioans For Concealed Carry has always been the efforts of our grassroots members. The ability to mobilize that base to contact their legislators has been crucial for gun rights reform in Ohio."

According to *Human Events*, a liberal "watchdog" group called Public Citizen actually spearheaded the effort to put these proposed regulations on Pelosi's radar screen. The package reportedly has a close similarity to Pelosi's "Honest Leadership and Open Government Act of 2006," which

gathered very little momentum in the last Congress. But with the change in party control, Pelosi's plan may now get traction.

But it will also face some stiff opposition, even outside the gun community. A spokesman for the Free Speech Coalition, Dick Dingman, told *Human Events*, "This is an effort that would become a major attack on the First Amendment." *The New GUN WEEK, January 20, 2007* 

## New Orleans Cops Indicted for Post-Katrina Murder, Shootings

More than a year after the city of New Orleans descended into anarchy in the wake of Hurricane Katrina, seven police officers in that city were indicted late last month on charges of murder or attempted murder.

The charges are related to two shooting incidents on the Danziger Bridge where hurricane victims were seeking refuge. According to Associated Press (AP), District Attorney Eddie Jordan described the indicted cops as having been "trigger happy."

"We cannot allow our police officers to shoot and kill our citizens without justification like rabid dogs," Jordan was quoted as stating.

The announcement brought a blistering reaction from gun rights a",ctivists who quickly argued that cops in New Orleans who confiscated firearms without probable cause or even legal authority should also face prosecution.

All the questionable shootings and the two killings occurred Sept. 4, about a week after the hurricane struck. Killed were 40 year-old Ronald Madison and 19-year-old James Brissette. Madison was shot seven times, and five of those bullet wounds were reportedly in his back.

The Danziger Bridge spans the city's Industrial Canal. It was "high ground" in a city inundated by flood water after levees failed in the hurricane's wake. Shots were fired by police after someone allegedly fired at workers from the US Army Corps of Engineers.

Indicted for murder are Sgt. Kenneth Bowen and Officers Robert Faulcon, Robert Gisevius and Anthony Villavaso. Charged with attempted murder are Officers Ignatius Hills, Robert Barrios and Mike Hunter.

AP reported that, according to a police report, New Orleans police responded to a call that two other officers had been injured. When the police arrived at the bridge, they reportedly saw several people running, and four of these people started shooting at them, so the police fired back. *The New GUN WEEK, January 20, 2007* 

# Homicides Rise In Some Major Cities in the US

Several US cities have experienced a spike in homicides in the past year, with the only decline in a

major city being New Orleans, primarily because so many people left that city and went elsewhere following Hurricane Katrina in 2005, according to Associated Press (AP).

Many of those people evacuated to Houston, TX, where not coincidentally according to police officials there, the city experienced a 15% increase in homicides.

New Orleans reported 154 murders last year, far down from the 210 posted in 2005. Crime in the Big Easy is back on the upswing; though, now that more people are returning to that city.

New York City had almost 580 killings through Dec. 24, up from last year's 539 murders but part of that is because victims of gunshot wounds or stabbings that occurred in the past died during the last year. There were 35 such deaths during 2006, according to AP.

Chicago reported a 3.3% increase in homicides, while New Haven, CT, reported 23 homicides as of Dec. 26, up from 15 in both 2004 and 2005.

The slight increase in Seattle, WA, murders, 29 last year over the 25 posted in 2005, can be attributed to a single event, the so-called Capitol Hill Massacre of March 29 in which a single gunman murdered six people at a party before taking his own life.

Oakland, CA, had 148 killings by Dec. 27, which is a 57% increase over the 2005 murder rate.

Philadelphia, PA, reported 403 murders by Dec. 27, which is up slightly from past years, when the number did not top 400.

In San Francisco, the murder rate fell about 15%, AP reported, while in Los Angeles, there was about a 4% decline with 464 killings posted through Dec. 23.

Many authorities blame the rise on drugs and gangs, with some also asserting that "easy availability" of guns is also a factor. *The New GUN WEEK, January 20, 2007* 

# Four Pistols Missing From Homeland Security

The Department of Homeland Security said on Dec. 26 that it is investigating how four handguns recently went missing from its headquarters in Northwest Washington, DC, according to The Press Democrat of Santa Rosa, CA.

Jarrod Agen, a department spokesman, said the guns belonged to Paragon Systems of Chantilly, VA, which provides security for the department's facility on Nebraska Avenue NW

"DHS is investigating the report," Agen said. "Paragon guns do not belong to DHS nor are they under the control of DHS."

A person familiar with the investigation and who requested anonymity while the probe is under way said four .40-caliber handguns vanished about two weeks before the

report dated Dec. 27 from a vault where Paragon security officers store their arms.

The newspaper's attempts to reach Paragon officials for comment the day after Christmas were unsuccessful.

## Teachers Armed As Thai Schools Reopen in South

Schools in parts of Thailand's violence plagued southern province Pattani reopened on Dec. 4 and teachers were allowed to take weapons to protect their own safety.

According to Thai News Agency, schools in seven districts of Pattani, one of the three southernmost provinces in Thai south troubled by insurgent unrest, including the provincial seat resumed classes after a one-week closure from Nov. 27 due to frequent attacks on teachers.

However, more than 100 schools in remote and violenceprone areas in the province remain closed. The teachers' confederation in Pattani said all schools in 12 districts were to reopen on Dec. 6.

School reopening depends on the decision of local school administrators. Some educational institutions may remain closed if they are not ready to resume classes due to lack of confidence in the government's ability to provide for the safety of teachers and staff, the report said.

Education Minister Wijit Srisaarn said he believed selfdefense measures, including allowing teachers to carry guns, will be effective in protecting the teachers. The educators themselves will also help security officials look after their colleagues, according to Wijit.

He said the ministry has already increased teachers' allowance to boost their morale and promoted temporary teachers to officially become civil servants. Only a small number of teachers have applied for relocation, he said. *The New GUN WEEK, January 1, 2007* 

### Philadelphia Gun Initiatives Target Parents and Businesses

The Philadelphia City Council is preparing to lower the boom on parents and guardians through a new gun law that could land them in jail for 30 days and trigger a \$2,000 fine if junior gets hold of a household handgun, according to The Philadelphia Daily News.

The Council is also looking to extend the hours of curfew for kids under 13 and to increase dramatically the fines for parents and guardians who let their kids run wild. Fines also would increase for businesses that let those kids hang around on their premises.

The two pieces of legislation moved out of the Council's Public Safety Committee on Dec. 5 along with another gun bill that would make illegal the failure to report a stolen or lost firearm.

Councilman Darrell Clarke, a co-sponsor of the gun bills, said the "failure to report" bill would require authorizing legislation from the state General Assembly, something that has not happened for a half-dozen other gun-control bills he's introduced along with Councilwoman Donna Miller. Those bills await final Council passage.

But after a careful analysis of state firearms laws, Clarke believes his latest attempt to stem the tide of gun violence in the city may pass legal muster.

"There is a window of opportunity to criminalize certain actions by the parent or guardian who allows access to dangerous weapons," he said.

While state law refers to "possession" of a firearm, Clarke's bill has language prohibiting children from "handling" or discharging a firearm and holding the parent or guardian responsible if they allowed the child to obtain unsupervised access to it.

The curfew law, which was introduced by Councilwoman Blon-dell Reynolds Brown, creates a new category for minors under 13 years old, the newspaper reported.

Under current law, all minors must be off the street during the school year by 10:30 p.m. during the week and by midnight on the weekends. The proposed law would require children under 13 to be in

side by 9 p.m. during the week and by 10 p.m on weekends.

After notice of a prior violation, a parent faces a \$150 fine, up from \$50, and fines up to \$500 after that. For a business, the fine rises to at least \$250, up from \$150. <u>The New GUN WEEK</u>, *January 1*, 2007

## Teen Imprisoned In Massacre Plot Admits Gun Thefts

A teenager imprisoned for plotting a massacre at his suburban Detroit, MI, high school in Mount Clemens has pleaded guilty to stealing two guns in an unrelated case, according to *The Macomb Daily*.

Andrew Osantowski, 19, also faces trial in two other cases.

Osantowski was convicted in June 2004 of threatening an act of terrorism and using a computer to threaten terrorism, after authorities found Internet chat room messages in which he said he might kill fellow students at Chippewa Valley High School. He was sentenced the following month to between  $4^{1}/2$  and 22 years in prison.

Defense attorney Brian Legghio asked in August that the other charges against Osantowski be dismissed, arguing that his client had been denied the right to a speedy trial. Macomb County Circuit Judge Kenneth Sanborn rejected that request in September and again on Nov. 28.

Osantowski then pleaded guilty to charges of burglary of a business, larceny and malicious destruction of property for the June 2004 thefts of an AK-47 assault rifle and a shotgun from a gun shop in Clinton Township. He is to be sentenced May 8. *The New GUN WEEK, January 1*, 2007

## Chicago Gunman Violated Gun Laws, Felt Cheated by Lawyer

Chicago tower gunman Joe Jackson violated at least two gun control laws in his fatal attack Dec. 8 in the office of an attorney he reportedly felt had cheated him on an idea he had for a type of portable toilet.

According to The Chicago 73~ibune, Jackson was accompanied by his pastor, the Rev. C.L. Sparks, when they went to the downtown office of a patent attorney whom Sparks reportedly believes was Michael McKenna, one of three people killed in the attack. At that meeting, the newspaper reported, Jackson gave the attorney an envelope containing \$5,000 cash as a retainer for doing work on a patent for his toilet idea.

But instead, The Tribune reported, Jackson later found a similar invention being marketed on the Internet. Jackson allegedly believed McKenna had pirated the idea, and an attorney hired by Jackson to sue McKenna reportedly found a patent for a device "similar" to the portable toilet issued to a woman who may be related to the slain attorney.

But in going after the attorney, Jackson evidently violated Illinois law against concealed carry, and also violated Chicago's ban on handguns. Jackson shot and killed

McKenna, attorney Allen J. Hoover, and retired teacher Paul Goodson, who was apparently a part time employee at the Wood Phillips law offices in the Citigroup Center. McKenna's paralegal, identified as Ruth Zak Leib, was wounded in the foot. Goodson, 78, reportedly worked at the firm delivering mail.

A police SWAT unit responded, and a marksman shot Jackson dead from about 25 yards, The Chicago Sun-Times reported.

This attack is slightly reminiscent of an attack on a San Francisco law office in 1993 in which a former client went into the offices of Pettit & Martin and other offices, gunning down 14 people, killing eight of them, before he committed suicide. That gunman, Gian Luiti Ferri, was angered over a real estate deal. He also violated several California gun laws, and his action provided momentum for more antigun legislation, while providing the catalyst for the birth of the Legal Community Against Violence, an organization of antigun attorneys.

The Chicago shooting occurred just after 3 p.m. on a Friday afternoon. Jackson apparently was motivated by years of frustration over his dealings with McKenna, who rented office space from Pettit & Martin and was not on staff

- COLORADO GOVERNOR LASHES OUT AT PETA... Colorado Gov. Bill Owens in a recent radio interview declared the anti-hunting People for the Ethical Treatment of Animals (PETA) are "a bunch of losers" and "frauds," reports the Center for Consumer Freedom. Owens' remarks were in response to a PETA spokeswoman saying the organization would not help Colorado ranchers with as many as 340,000 cows and steers left stranded by recent snowstorms.
- STATES REPORT SURGE IN YOUTHS
  HUNTING ... Since NSSF helped launch Families
  Afield in 2004, 12 states have adopted new laws
  welcoming youths and other newcomers into hunting.
  Two of those states, Michigan and Ohio, also created
  apprentice hunting licenses allowing novices to give
  hunting a try under the watchful eye of an experienced
  mentor. First-year results appear extremely promising.
  More than 17,500 apprentice licenses were sold in
  Michigan, plus over 7,500 in Ohio, during 2006. These
  25,000 new hunters suggest a 23 percent jump in the
  two states' combined population of hunters age 15 and
  under. NSSF's partners in Families Afield include the
  National Wild Turkey Federation and U.S. Sportsmen's

- **NEWS REPORT: ATF REVOKED 131 FEDERAL** FIREARMS LICENSES IN 2006 . . . According to troubling statistics obtained by the Baltimore Sun, the Bureau of Alcohol, Tobacco, Firearms and Explosives revoked nearly six times as many federal firearms licenses last year as compared to 2001. "We are concerned about this seemingly sudden spike in license revocations and will attempt to determine why so many more dealers are now having their license revoked by ATF," said Lawrence Keane, NSSF senior vice president and general counsel. "This statistic would appear to further demonstrate the need for reforms and improvements to ATF's licensing and enforcement powers, including alternative sanctions short of revocation." Legislation in the last Congress (H.R. 5092) passed the House by a broad bi-partisan margin but died in the Senate when it was blocked by Sens. Chuck Schumer (D-N.Y.) and Dianne Feinstein (D-Calif.).
- CONGRESSIONAL SPORTSMEN'S CAUCUS NAMES LEADERSHIP... As the 110th Congress officially begins Thursday, the Congressional Sportsmen's Caucus has announced new leadership to serve as the stewards of sportsmen's issues during the two-year session. Serving as co-chairs in the Senate will be Sens. Max Baucus (D-Mont.) and Mike Crapo (R-Idaho). The House co-chairs will be Reps. Ron Kind (D-Wis.) and Paul Ryan (R-Wis.). The caucus vice-chairs will be Sens. Ben Nelson (D-Neb.) and John

- COURT SIDES WITH SCI, DUCKS UNLIMITED, FISH & WILDLIFE SERVICE... The Court of Appeals for the District of Columbia Circuit has ruled in favor of Safari Club International, Ducks Unlimited and the U.S. Fish and Wildlife Service in an appeal brought by the animal rights group Fund for Animals concerning Maryland's ability to manage the invasive mute swan. The Fund for Animals had sued USFWS claiming that it violated the Migratory Bird Treaty Act (MBTA) by removing the mute swan from the list of birds protected by that act. SCI and DU intervened and helped the federal government defend the case.
- NSSF DEALER TIP TO ATF BAGS ILLEGAL STRAW PURCHASING GANG . . . Army & Navy, a Whitehall, Pa., firearms dealer that had earlier received NSSF's Don't Lie for the Other Guy dealer kit, suspected something was not right when two men handed over \$1,400 to a woman they hardly knew so she could buy them three handguns. The employees tipped off ATF, which resulted in the federal court indictment announced Friday of a straw purchasing gang that was illegally trafficking firearms to the criminal black market for guns in New York City. A store spokesman told The Morning Call, "When we smell something funny, even the slightest indication that something is funny, we stop the sale. This is a tremendous responsibility, and we take it very seriously." NSSF senior vice president and general counsel Lawrence G. Keane applauded the actions of Army & Navy, noting that ATF has informed the industry that many firearm investigations and prosecutions are the result of tips they receive from firearm dealers. "We are pleased to see the Don't Lie for the Other Guy program in action," Keane said.
- VICTORY FOR OHIO GUN OWNERS... The Ohio Senate last week followed in the footsteps of the state House by voting to override Gov. Bob Taft's veto of legislation that will create statewide preemption regarding firearms laws and regulations. This action will ensure that municipalities cannot pass gun-control measures more stringent than that of the state. The bill will bring uniformity to Ohio's gun laws by preempting an estimated 80 local laws, including those restricting right-to-carry.
- JUDGE: HANDGUN ORDINANCE VIOLATES LAW... A state court judge last week ruled a Jersey City ordinance limiting handgun purchases to one gun a month violated the state's preemption laws, recognizing that the state of New Jersey has already enacted comprehensive regulations regarding the acquisition and sale of firearms and that municipalities do not have the right to enact additional gun-control measures. "Restricting the rights of law-abiding citizens and

bullying lawful firearms dealers is not the way to curb violent crime," said New Jersey Association of Firearms Retailers (NJAFR) president Bob Viden. "Judge Gallipoli made the right decision. State law must preempt any attempts by localities to unfairly restrict or hinder our constitutional right to keep and bear arms." The lead plaintiff in the case was NSSF and NJAFR member Frank Caso (Caso's Gun-a-Rama). Published reports indicate Ceasefire NJ and the city of Jersey City intend to appeal this decision.

- MICHIGAN LEGISLATURE PASSES
  EMERGENCY POWERS PROTECTION ACT...
  A two-bill package, passed in the Michigan State Senate and House by votes of 37-1 and 105-0, respectively, prevents local governments from confiscating lawfully owned firearms during a state of emergency, as witnessed in New Orleans following Hurricane Katrina. In the first year since Hurricane Katrina, 10 other states and the federal government have passed similar legislation.
- CITY FILES SECOND LAWSUIT AGAINST FIREARMS DEALERS ... New York City Mayor Michael Bloomberg announced last week that the city has filed a second lawsuit against 12 additional out-of-state gun dealers. The lawsuit is similar to a suit filed in May against 15 out-of-state dealers, which potentially jeopardized more than a dozen ongoing criminal investigations. The suit filed last week names firearms dealers in Georgia, Ohio, Pennsylvania, South Carolina and Virginia.

- OHIO HOUSE OVERRIDES GOVERNOR'S
   CONCEALED CARRY VETO . . . For the first time in his eight years as governor, Bob Taft saw his veto overridden by a chamber of the state legislature. The bill in question, H.B. 347, amends the state's existing concealed-carry law, and the governor objected to its pre-emption of local regulations. The state's Senate must also override the governor's veto for the bill to become law.
- D.C. ATTORNEYS WISH TO RE-INTERPRET SECOND AMENDMENT . . . In a case that could shape firearms laws nationwide, attorneys for the District of Columbia argued last week that the Second Amendment's right to bear arms applies only to militias, reports The Washington Times. The attorneys are attempting to defend as constitutional the district's ban on handguns as it argues before the U.S. Court of Appeals.

A consultant hired to study the issue said 65 percent of the state's population opposes Sunday hunting, while 25 percent supports it.
